**GLOSSARY:**

**“Commercial Rental”** means commercially renting and making available the sound, music videos and/or karaoke recording to the public for the sole purpose of public performance, e.g. sound, music videos and/or karaoke recordings from DJs, Emcees, Music Equipment Suppliers, Event Managers, Jukebox Operator and etc.

**“Featured Entertainment”** means the playing of sound, music videos, and/or karaoke recordings as the main feature of entertainment and includes music for entertainment, product launches, dancing, karaoke singing and entertainment provided by disks jockeys.

**“Non-Featured Entertainment”** means the playing of sound recordings, and/or music videos where it is not the main feature of entertainment e.g. Background piped-in music including Radio/TV broadcasts.

**“Music Entertainment”** means the playing of sound, music videos and/or karaoke recordings in public.
